MISDEMEANOR INFORMATION

NOW COMES the State of New Hampshire, by and through John Webb, Assistant Cheshire County Attorney, and **PRAYS to INFORM** this Honorable Court that a person referred to herein as John Doe (real name unknown), the Defendant, on or about September 23, 2011, at Keene, in the Cheshire County Superior Court, in said County and State did commit the offense of **CONTEMPT of COURT**, by knowingly violating an order to not bring certain camera or audio equipment into the Cheshire County Superior Court lobby, beyond the security checkpoint, in violation of instructions issued by bailiffs in charge of security at the courthouse entrance, which bailiffs were attempting to enforce the order (effective July 1, 2011) of the Honorable Tina Nadeau, Chief Justice of the Superior Court, against the peace and dignity of the State.
