**The court process:** If the king wishes to take the ticket to court, his men will schedule a “pre-trial conference” (PTC) and notice should be sent to your address. The prosecutor will likely offer you a deal at the PTC. You don’t have to agree to it and can always counter-offer to a better deal. While at the PTC, if you intend to go to trial and clog the system further, submit a written request for discovery to the prosecutor and court clerk. This will require the prosecution to deliver a copy of all evidence and a witness list to you.

If you make it to trial, the parking enforcer will present his or her case against you. You will have the opportunity to question the enforcer. You do not have to take the stand. If you are found guilty, consider asking for community service instead of paying the fine.
