
Dear Mr. Horton:

The City of Keene Police Department hereby denies your application for a license to carry a loaded pistol or revolver. On July 02, 2014, your pistol permit application was received. Your application was reviewed pursuant to RSA 159 and determined that you have had several contacts with the police for assaultive or threatening behavior within the last three years. Specifically: an arrest on 09-09-11 for Obstructing Government Administration and Resisting Arrest; an arrest on 09/14/11 for Possession of Controlled/Narcotic Drugs and Common Law Criminal Contempt; an arrest on 02/27/12 for Criminal Trespass, Resisting Arrest and Common Law Criminal Contempt; and an arrest on 3/30/12 for Resisting Arrest, Disobeying an Officer and Common Law Criminal Contempt; for this reason, the Keene Police deny your pistol permit application pursuant to RSA 159:6.

The denial of your application for a license to carry a loaded pistol or revolver is without prejudice, meaning that you may resubmit an application for consideration. Under RSA 159:6-c, you have the right to appeal this decision by petitioning the Keene District Court within 30 days of today's date.
