

## Notice Regarding Citizenship

I, Ian B Freeman, am updating my voter registration based on my current knowledge to reflect new information that has become clear to me and important to get on the record.

The "State of New Hampshire", like all groups of men and women calling themselves "government" in 2018, is clearly an entity claiming a monopoly on violence. Despite its constitution's Article One of the Bill of Rights that says government of right is founded in consent, the State of New Hampshire will not recognize or respect the individual who wishes to opt-out. It is clearly not acting as a government of right and instead a government of wrong.


I've made my lack of consent clear in various court and governmental filings, but the people of the State government don't care about their own constitution until its forced on them by their own Supreme Court.

Until such a time that the people calling themselves the "State of New Hampshire" actually start allowing peaceful people to voluntarily fund its programs and stop using institutionalized aggressive force, and because they continue to force themselves on me, I will accept its state citizenship under duress and invoke Article Ten of the NH Constitution, the right to revolution:

*Government being instituted for the common benefit, protection, and security, of the whole community, and not for the private interest or emolument of any one man, family, or class of men; therefore, whenever the ends of government are perverted, and public liberty manifestly endangered, and all other means of redress are ineffectual, the people may, and of right ought to reform the old, or establish a new government. The doctrine of nonresistance against arbitrary power, and oppression, is absurd, slavish, and destructive of the good and happiness of mankind.*

Given your agents have forced me under duress to become a citizen of the State, (judge Edward J Burke in Keene even threatened me with aggressive violence if I didn't get a NH driver's license), I did some research on state and U.S. citizenship.

According to U.S. Supreme Court case Hooven & Allison Co. v. Evatt, 324 U.S. 652 (1945), "the term "United States" may be used in any one of several senses. It may be


merely the name of a sovereign occupying the position analogous to that of other sovereigns in the family of nations. It may designate the territory over which the sovereignty of the United States extends, or it may be the collective name of the states which are united by and under the Constitution."

New Hampshire was a sovereign state when its representatives joined with others in forming the United States. It still holds that status today and can exit the union at any time, as a free state. According to U.S. Supreme Court case United States v. Cruikshank, 92 U.S. 542 (1875), "There is in our political system a government of each of the several States, and a Government of the United States. Each is distinct from the others, and has citizens of its own who owe it allegiance, and whose rights, within its jurisdiction, it must protect. The same person may be at the same time a citizen of the United States and a citizen of a State, but his rights of citizenship under one of those governments will be different from those he has under the other."

When a document that I have signed, such as this voter registration, refers to me as a "US Citizen" or "U.S. Citizen" or "United States Citizen", I am agreeing to that only under the third definition of United States as provided by the Hooven case, where "United States" refers to the collective name of states, and the "Citizen" referring to my status as a New Hampshire State Citizen, under duress. I operate as a US Citizen by standing on my State of New Hampshire Citizen status while rejecting any Federal Citizen status.

Upon receipt of this notice, if you believe any of the research is incorrect, please reply in writing to the address below with your rebuttal within 30 days, otherwise I will presume you agree with my conclusions and accept this document as fact.
