I ROBERT B HARRINGTON being duly sworn, depose and say:

1. I have arrested:

I have information that a crime (or offense) has been committed by the defendant as follows: Disorderly Conduct M 644;2

Thurs April 20,2017 at appox. 2249 hrs.,I was working a court authorized DWI check point detail ,with other members on the MPD Traffic Unit.

We had set up according to plan on the west end of the Bridge St. Bridge. The road way was marked off with large signs, traffic cones and marked Police vehicles with emergency warning lights on. The cone patterns were set up directing auto traffic in to two bays for screening. The side walks on the north side of this one way span had clearly been posted with reflective signs indicating that the side walks were closed by our vehicles and bays. The side walk on the south side of Bridge St was open to pedestrian traffic. An island separates the two one way spans heading E/W across the Merrimack River.

As we were working the bays, I observed several subjects on the south side of the traffic lanes. They were on the side walk by the apartment building, and appeared to be watching us work. I then observed both subjects cross the road way, not in a cross walk and approach us. They were stopped on the traffic median. I asked both subjects to halt, and walked over to them. One of the subjects then started to asked me about a court decision, and had a video camera in his hand. He moved the camera toward my face in such a way as to cause me concern that he would strike me. I reached out and pushed the camera away from my upper body and held it while I attempted to talk to the subject. He refused to listen, and started to yell at me about his rights and safety.

At this point in time, i had decided that it was proper to issue this person a summons, REF Ped. in the Road way, and he had clearly crossed two lanes of traffic not in a cross walk that was located at the intersection. This intersection is controlled by traffic lights and had WALK signals as well.

I asked the subject to produce an ID so that I could write out a summons. He stated that he had no obligation to ID him self unless he was under arrest. I then asked him several more times, hoping that he would comply. He refused to do so ,and was taken in to custody at that time. He was brought over to my car, and hand cuffed as per MPD SOP. I double checked the cuffs to make sure that they were not too tight ,and were fitted properly. When the wagon arrived for transport, the cuffs were checked again and double locked. he was searched on the street, and a phone an other items including a wallet were placed in to a paper bag for transport to MPD HQ.

A NH Drivers license was located IDing this male as CHRISTOIPHER WAID 09 12 1984 of Keene NH .He was transported back to the department booking room,and booked as per SOP. He was charged with DOC M , 644;2 M . The video camera he had was seized and placed in to evidence.
