Regards My Candidacy For Mayor: I feel that present Mayor, George Hansel, and I have a true and lasting friendship and great rapport, almost like "father and son", as is evident from our discussions on his 7:00 AM - 9:00 AM, Saturday morning show on WKBK Radio, (See WKBK website for Mayor George Hansel's pod casts and please ask Dan Mitchell to restore George's podcast of 07/31/2021, where George and I discuss Dan's segment on Friday mornings, 7:12 AM - 7:25 AM, with his political guest, Arnie Arnesen).

I feel strongly that George has forgotten our men and women presently fighting for our freedoms and our veterans, many of whom suffer from PTSD. This, as per my calls to him after he attended the Black Lives Matter and "Juneteenth" rallies especially in June 2020, when N.H. Governor Chris Sununu had a stay at home order in place. Radius) and computed live on George's show, the approximate number of persons who should have occupied this to be the area of the Central Square meeting place / Area Occupied by individuals @ 6 Ft. social distancing (3 ft. radius around each person) to be

- = PI*(60 Ft.)^2 / PI*(3 Ft.)^2
- = PI*(20*3 Ft.)^2 / PI*(3 Ft.)^2
- = 400 persons standing in a circle of radius of 3 ft. with the outer edges touching for each person to maintain 6 ft. social distancing.

And I took photos and not everybody was wearing masks. And promoters drove cars around the circle with people hanging out the windows shouting support; also without masks.

Furthermore, some protesters had anti-police signs and so I felt bad for our good police officers. Thus, I made peace by speaking with the City of Keene police officers who were stationed at the City Hall, UCC Church and Mexican Restaurant sides of the perimeter. And I thanked them for their service and told them that I did not associate them with the police officer, Derek Chauvin, who had knelt on the neck of George Floyd in Minneapolis. After all, it is not our police officer's fault that this happened a

I am my own man and an atypical candidate in that I will continue to work to support Mayor Hansel, the City Council and all other offices as best as I am able, throughout the primary and election processes, and beyond, working in the best interests of the City of Keene and its' citizens.

And perhaps a contest centering around my extensive "vanity license plate" photo collection. Listeners could call in to interpret the meaning of the plates. And how 'bout variety shows, involving any and all Keene residents, at the Colonial Theater, every TBD months designed to further introduce City residents to one another in order to build a sense of unconditional love, trust, fellowship and community. And dances, especially for our youth, as was proposed to me by Veteran friend, Joe Trudelle, who runs the VFW on Winchester Street. Look, it's your city too, so let me know what you want to do!!

Here are a few examples of suggestions to me, from the great citizens of Keene and outside of Keene, that I compiled in my listening and discussing things with my veteran and non-veteran friends at McDonald's the past few days. I offer this to the present mayor, George Hansel, and city council, to use any of these ideas immediately. This, because I do not believe in party politics and think it's a disgrace to hold back information for political gains later. And I'm greatly disappointed in our present system where outgoing presidents, senators, representatives, etc., don't support and mentor the incoming parties. - 1.0) Ad Hoc Committee To Study And Propose Requirements Regards COVID-19: On Mayor Hansel's Saturday morning show of August 28, 2021, with followup as our cars were side by side near the WKBK radio station on Stanhope Avenue, I proposed that he form an ad hoc committee to study and propose reguirements regards COVID-19, to the City Council & Mayor. This, with experts on the conventional medicine side, such as Dr. Don Caruso, MD, MPH, President & CEO, Cheshire Medical Center, and Dr. Aalok Khole, MD, Infectious Diseases Physician at CMC, and experts on the Holistic Healing Side, including Rebeca Montrone, Certified Nutrionist and owner & operator of Wondrous Roots, Inc., et.,al. This, instead of airing our "dirty laundry", via debate on air on WKBK radio, as is the case at present. Mayor Hansel indicated that he will think about it.
- **2.0)** Read My Lips Let's Improve OurTax Base: As suggested by my veteran friend, Joe Trudelle, who runs the VFW on Winchester Street, and a slight tweak by myself in evolving this solution, suppose we give our senior citizens a floating point tax break, to 70% of the present tax rate, for a given year. They would pay this 70% of annual tax rate until they pass away. Then, the next owner, ideally a son or daughter of age less than 70, would pay the 100% tax rate plus the floating point back taxes of the person who passed away. This would be ideal In an inheritance situation, and should be achievable, because the younger person would not have to be paying on a mortgage (or paying rent) wherefore they can more easily afford to pay the back taxes in addition to the 100% tax rate.

- **2.1)** As suggested by my veteran friend, Terry Bishop, the mayor should check in with all the (major) businesses in the city and ask them, "how can I help you to be successful and stay in Keene to contribute to our tax base?": This immediately made good sense to me because in my engineering design & test work for defense contractors, my V.P. of engineering used to ask me a similar question, "what personnel and test equipment do you need to be efficient and successful in your design and test work?"
- **2.2) Don't Over-Inspect Me Out Of Keene:** And my veteran friend, Doug Hill, added, that we need our inspectors to be more reasonable in inspecting these businesses. For example, if an outlet is 7.5 inches off the floor instead of 8.0 inches, then if is not a hazard to be at 7.5 inches, then fill out paperwork to seek a waiver instead of making the establishment rip the outlet out and re-install it. Same thing with the marquee on our businesses where I heard that the city made CVS chang the color, etc. How ridiculous!! Do you want the businesses to remain or move elsewhere!!
- 3.0) How Many Rotaries Do We Need In Less Than A Mile On Island & Winchester Streets?: My personal question is, what are the engineers / designers trying to achieve regards traffic flow? The present flow appears to be working just fine. Furthermore, towards resolving this question, I spoke with Dan Frazier, V.P. of Operations at McDonald's, who was at their Keene restaurant, who started out in 1981 as a "crew kid". He informed me that back then, McDonald's opposed the installation of medium strips because it impeded the flow of traffic into their restaurant from cars heading north. Interesting that some years later, this solution was preferred because it helps the flow of traffic in disallowing left turns out of their parking lot which would cause cars to back up in their drive up window and exit paths. I also, discussed this with my veteran friend, Joe Trudelle, a former tractor-trailor truck driver. We noted that delivery trucks (and there are some huge ones into McDonald's for example) may have issues negotiating if the rotaries don't have sufficient turn radius.
- **4.0)** The Present Conditions Of Some Apartments Don't Command Such High Rental Prices: As per my veteran friend, Sherri Garland, resident of Marlborough, N.H., and past Commadent for Marine Corps and present Paymaster for Marine Corps League (prior Marines), housing prices are too high in Keene. Landlords have a "captive audience" and base rents on Keene State College prices. Many apartments are not up to snuff and rent is exhorbitant for the given conditions. The Landlords should either drop the rental prices or renovate the apartments, using the monies that they overcharge by, to conditions that command the higher rental prices.
- 5.0) Let's Teach The Elementary And High School Students Some Healthy, Family & Patriotic Based Local Patriotic History:
 As per my veteran friend, Sherri Garland, to commemorate the 50th anniversary of the end of the Vietnam War, the American Legion in Brattleboro, Vermont, in cooperation with Hinsdale, N.H., held an outing to honor all of the military personnel in the area who had served in Vietnam. High school students were each assigned to go one on one and do a biography of a "soldier" who had died, from birth to date of their death. This included visiting the families who showed the students photos of the deceased in effect bringing them alive to these kids. These biographies were presented at the outing and was a big success!

Furthermore, in Marlborough, the students were involved in commemorating Veteran's Day in making and presenting cards of thanks and gratitude to living veterans.

I agree and tongue in cheek ask, why is it that we all seem to love some of the old fashioned activities such as the "sock hop" dances of the 1950's, and yet we won't hold one today. The goal is mingling and having some good, honest fun!!
- 7.0) More On My Biography A Call To Prayer Faith, Family & Friends: In my 30 years working as a design electrical engineer for defense contractors, I recognized that, as prophesized in the Holy Bible, that God is keeping His promise to His "chosen people" (e.g. the Jewish people), and is taking care of them for all time. Most recently, and 3 years after witnessing the ashes from the burning Twin Towers falling on our Long Island home, my son, Steven, enlisted in the United States Marine Corps at age 18, served working in IT in 29 Palms California, and received an honorable discharge after being injured in-country. And my nephew, Austin Stobaugh (my sister-Yolanda, and her husband, Robert Stobaugh's, son) served as a marine pilot, flying the Osprey in rescue and relief missions including the typhoon in the Philippines and earthquake in Nepal and many things that he has not had time to describe to me. He is presently serving in the U.S. Navy after a COVID shortened employment as a commercial airlines pilot with Delta Airlines.

Also delving further into family history, we see that through marriage of my dad's sister – my Aunt Rose Zuchowski, to John M. Lipski, a wonderful, generous, loving uncle and man of faith, the Zuchowski Family is linked to Lt. Commander Stanley Lipski who was 3rd in command on the U.S.S. Indianapolis, that, in July 1945, completed a top-secret high speed mission in delivering parts of "Little Boy", the first atomic bomb used in warefare, to the South Pacific, where it was subsequently assembled with the rest of the pieces and dropped on Hiro Shima.

The ship subsequently departed on a training mission in the Philippines. At 0015 on 30 July, the ship was torpedoed by the Imperial Japanese Navy submarine *I-58*, and sank in 12 minutes. Of 1,195 crewmen aboard, approximately 300 went down with the ship. The remaining 890 faced exposure, dehydration, saltwater poisoning, and shark attacks while stranded in the open ocean with few lifeboats and almost no food or water. The Navy only learned of the sinking four days later, when survivors were spotted by the crew of a PV-1 Ventura on routine patrol. Only 316 survived.

Excerpted from my home town area newspaper, (copy attached as pdf file for submittal to Keene City Clerk's Office and Sentinel Newspaper, 2001_07_29__DailyHampshireGazetteArticle_Cmdr.StanleyLipski_USS-Indianapolis.pdf), the Daily Hampshire Gazette, Northampton, Ma., article of July 29, 2001, we see that as per an eyewitness account by close friend and survivor, the ship's physician, Cmdr. Lewis Payne, the 34 year old Lt. Cmdr. Stanley Lipski, after working gallantly to help wounded men into life vests, went into the sea with his eyes burned close and his hands burned down to the tendons. A dozen men struggled to hold him out of the seawater and oil until he died that evening. To his close friend, Cmdr. Lewis Payne, the ship's physician, the 34 year old Lipski murmered, "Lew, I'm dying. Please tell my wife I love her. Tell her I want her to marry again".

Also, embedded herein below are a commemorative postcard and envelope from the dedication of the new U.S.S. Indianapolis, dedicated on July 30, 1977. My Uncle John & Aunt Rose attended the dedication and although they have a son and two daughters, my Uncle John entrusted me with these as a family keepsake souvenir!!

My brother, **Allan, honorable owner of the Zuchowski** Family Farm - Lazy Acres Farm, in Hadley, Massachusetts; an honorable, hard working farmer, with a degree in U.S. History, who would not compromise his patriotic values in his tearing pages out of his final exam "blue book", at UMass, Amherst, in taking a final exam in economics, taught by a Marxist, and who is one of the best, scholarly and "hands on" historians that I know, not to mention a man who would only be 3rd behind Jesus Christ and John the Baptist, if I had a choice as to who would baptize me as we worked thousands and thousands of hours side by side in working on the family farm, know, love and trust one another unconditionally, once spoke with the bombardier, Thomas Ferebee. Thomas sensed Allan's hesitation to ask

A salute to the men of U.S.S. INDIANAPOLIS (SSN 697) From the survivors of U.S.S. INDIANAPOLIS (CA 35)

This commemorative cover marks the launching of the newest United States Navy vessel to bear the name Indianapolis. The launching takes place 32 years to the day after the cruiser U.S.S. Indianapolis (CA35), then flagship of the U.S. Fifth Fleet, was torpedoed by the Japanese submarine I-58 on July 30, 1945 in the closing days of World War II.

Of the 1,196 men aboard CA 35, 880 died—the heaviest loss of life in a single vessel in the Navy's history. Of the 316 men who survived, more than 200 are still alive and nearly all belong to the U.S.S. Indianapolis (CA 35) Survivor's Association.

It is these men and their families who send greetings today to the new U.S.S. Indianapolis (SSN 697) and to the men and women who will serve her.

City sailor died on the Indianapolis

Once again, on July 30, the death of Cmdr. Stanley W. Lipski, who went down with the USS Indianapolis on July 30, 1945, will be recalled by his three remaining siblings: Stacia Dialessi of Agawam, Bertha Wronski of West Springfield, and Walter Lipski of Northampton, who lives in the old family home at 3 Ferry Ave., Mount Tom.

Stanley Lipski was one of the 12 children born to Anthony and Martha Lipski, who emigrated to this country before the first world war. His father arrived in Northampton in 1901, at age 18, and sought work at the so-called "pulp mill," or Mount Tom Sulphite Co. Rejected initially as too thin, Anthony Lipski won himself a job by seizing and toting a large log with ease. He worked there all his life, and during the Depression was guaranteed at least three days' work each week. When Martha Lipski died in 1928, the older daughters took over the housework and mothered the younger children.

As a student at Northampton High School, Stanley distinguished himself academically and also at basketball while holding an after-school job for four years in the Blanc-Levin Pharmacy at 48 Main St. He graduated in 1931 and passed the exams for both the U.S. Military Academy and the Naval Academy. Congressman William J. Granfield appointed him to the latter, his first choice.

Graduating in 1935, Lipski was sent to Pensacola, Fla., for a year's course in naval aviation. After two years of sea duty, he was assigned to naval intelligence and was with the American legation in Berlin at the start of World War II in September of 1939. After the fall of Poland, and aided by his proficiency in Russian, Lipski was stationed in Moscow followed by periods in Latvia, Finland and Sweden.

In 1940, a year before this country entered the war, Lipski launched a personal campaign to return to sea duty. "This is going to be quite a war," he told his sister, Stacia. "If I have to die, I want to be at sea and die a hero." In March of 1943, Lipski was assigned as gunnery officer, and thus third in command, of the heavy cruiser USS Indianapolis. "Well liked because of his competence and good humor," according to a shipmate, he was also respected for his determination to get back on a ship.

By the summer of 1945, Lipski and the Indianapolis were veterans of

year at a cost of 2,124 American lives. Here, McVay was ordered to report next at Leyte, in the Philippines, for the Indianapolis to prepare for a role in the imminent assault on Japan.

After 31/2 years of use by the Navy, the 1,300-mile route between Guam and Leyte was considered "routine transit." Some 5,000 ships had sailed the route over the previous 10 months. It was here on Guam, however, that the USS Indianapolis, through a fatal mix of bureaucracy, secrecy, preoccupation, complacency, inefficiency, and perhaps a touch of paranoia, was doomed. With a ship that had no antisubmarine device, Captain McVay was denied a destroyer escort. Officials on Guam knew, moreover, that enemy subs still prowled the Philippine Sea. Only two days before the Indy left, one had sunk the destroyer USS Underhill, part of a convoy, with the loss of 112 lives.

trition. Salt water drinkers suffered seizures ending in coma. Some men drowned themselves. Fifty were killed by shipmates, suffering hallucinatory dementia, who took them for the enemy. Sharks feasted on at least 200 men in their last great banquet of American sailors in WWII. In the cruel sea, 808 enlisted men and 67 officers would die while, on Leyte, the Indianapolis was listed merely as "overdue."

On Thursday morning, Aug. 2, out on a routine patrol in search of subs, a Navy pilot, Lt. Wilbur Gwinn, dropped his Lockheed Ventura PV-1 to 300 feet after spotting, quite by accident, some "little black balls" on a vast oil slick, the heads of the 321 men left alive of the Indy's crew. By dawn the next day, all had been rescued. Four died in the hospital, reducing the survivors to 317.

Even before the Navy court-martialed him, McVay, who had survived, would conclude, "I should have gone down with the ship." In U.S. naval history, he is the only captain to be court-martialed for the loss of his ship sunk by an act of war. After a long, hard struggle by those interested, including some Indy survivors, McVay was "exonerated" on Oct. 12, 2000, by a Congressional amendment, "for the loss of his ship and so many of his crew." His conviction, however, still remains on his record. The captain shot himself in 1968.



combat. The officer had earned nine battle stars, and the Indy, as her crew called her, was undergoing repairs in the Mare Island shipyard north of San Francisco, for the nearly fatal damage inflicted during a kamikaze attack at Okinawa in March. Nine men were killed and 29 wounded.

On July 12, Capt. Charles B. McVay returned to his ship from a meeting at naval headquarters in downtown San Francisco with orders to have his ship ready to sail only four days later. At Hunters Point, a supply depot in San Francisco Bay, they were to take on board a mysterious cargo labeled "Secret Project." On reaching the specified distance from land. McVay opened his sealed orders. "Men," he announced over the intercom, "this is a speed run to the Island of Tinian. We can't lose time. All hands be sharp. That is all." On that same departure day, July 16, Cmdr. Mochitsura Hashimoto was exiting the Japanese naval base at Kure, in the I-58, one of his country's last six submarines. In four years of war, he had yet to sink an enemy ship.

Unknown to her crew, the enormous wooden crate and small metal canister taken aboard the Indianapolis at Hunters Point, contained the components of the world's first atom bomb and the requisite amount of uranium-235 which, on Aug. 6, would all but obliterate the Japanese city of Hiroshima. The 13-year-old ship made the 5,000-mile voyage in 10 days. After delivering the "Secret Project," the Indy with its crew of 1,196 was to head for Guam, won the previous

On the night of July 29-30, Hashimoto of the I-58 detected the Indianapolis, 350 miles from landfall, en route to Leyte. At 12:05 a.m., two of his six torpedoes hit her. The first tore away the bow; the second hit her amidships on the starboard side, igniting 3,500 gallons of high-octane aviation fuel. Some 300 men were blown up, burned to death or drowned. "We've been badly damaged, Charlie ... I think we are finished," reported Cmdr. "Joe" Flynn, executive officer of the ship, to McVay. "Abandon ship!" was ordered. She sank at 12:14 a.m. on Monday, July 30. Four distress signals had gone out and been received but set aside as enemy "tricks."

Lipski, after helping wounded men into life vests, went into the sea himself with his eyes "burned closed" and his hands "burned down to the tendons." A dozen men struggled to hold him out of the salt water and oil until he died that evening. To his close friend, Cmdr. Lewis Payne, the ship's physician, the 34-year-old Lipski murmured, "Lew, I'm dying. Please tell my wife I love her. Tell her I want her to marry again."

For almost four days, a few men on rafts, some clinging to floater-nets, and others only with life vests ("the swimmers"), struggled to stay afloat in a vast sea of oil, debris and dying men. Eventually this stretched 20 miles. Men died at a rate of one every 10 minutes. Causes of death included dehydration, hypothermia, wounds, pulmonary edema, shock, exhaustion and malnu-

At 8 p.m. on Aug. 14, 1945, President Harry S. Truman announced the war's end. The Navy then released the following: "The USS Indianapolis has been lost in the Philippine Sea as a result of enemy action. The next of kin of casualties have been notified." Two days earlier, the Navy had begun sending "missing in action" telegrams to the parents and wives of the dead. Some of these arrived at homes even as the president spoke. Lipski's father was asked to pick up his telegram at the office on Main Street. "Don't come alone," he was advised, "have someone with you." A "secret" phone call from Stanley's friend and survivor, Lewis Payne, is how they first learned of his death, according to the family.

Another son of Northampton, Pharmacist's Mate Russell Morey, escaped Stanley Lipski's fate by the skin of his teeth. A transfer he had requested following his marriage came through one day before the Indianapolis sailed off into history. Morey remembers the day he discovered Lipski's name and birthplace on a shipboard list. "I got on the ship's phone and identified myself to him. Even though I was just an ordinary sailor, he arranged for us to meet. We talked for quite a while, and he was very nice to me." His Navy ID card, which Morey carries to this day, bears the signature of Joseph A. Flynn, who, like Lipski, died with the Indianapolis.

When you were a young child, you had wavy brown hair, dark eyes and somewhat garbled speech due to an impediment. In short, you were adorable, As I arrived home from work, I enjoyed how you would put your arms straight up in the air wanting to be picked up. This made me feel good and I would chuckle because you looked like a football referee indicating that a field goal attempt was successful. It made the long hard work day worthwhile. I love you very much too.

As you grew older, you took an interest in the work that I did around the house. You never complain, have an easy going nature and are very dependable when asked to help around the house. This is appreciated very much by mom and me. Also, I'm proud of your school accomplishments. You have been diligent taking the extra lab courses and all of those math and science courses. You have virtually enough credits to graduate now, at the beginning of your senior year, which is totally awesome. The interest, intelligence, diligence, positive attitude and dependability are good qualities that should be an asset to you in whatever you choose to do with your life.

As you approach adulthood be aware of family health history which includes cancer, depression, diabetes, heart problems, autism and aneurisms. Take care of yourself and never be ashamed to confide in a doctor or loved ones (certainly mom and me) any ill feelings be they physical, mental, emotional or spiritual. This is very important advice. I say again, never think that you are alone with any problems that you may have. Your immediate and extended family all care about your well being. Come to us with any problems.

Oh yes, there's one more family illness. Red Sox fever. In the Fall of 1986, I sat holding you, feeding you a bottle while bouncing you on my knee, watching Game #6 of the World Series between the Boston Red Sox and New York Mets. The Sox had the lead in the bottom of the 9th and were one out from winning their first World Series since 1918. All the pain that I had suffered in following them since 1967 including the the World Series losses to the Cardinals in '67, and to the "Big Red Machine (Cincinnati Reds) in '75, both in 7 games, and the Bucky Dent homer in the pennant deciding game between the Sox & Yankees in '78, were about to be erased. I fed you and rocked you. You were becoming a milk shake. Your mother reached out to rescue you, the ball went through Buckner's legs, I dropped you on your head (not really), and you've been a Red Sox fan ever since. You have the dreaded Red Sox fever.

In seriousness, it's fun that you've taken an interest and follow sports with me. I enjoy the closeness and companionship that we share. But try not to take it too seriously. I felt sorry for you when the Sox lost to the Yanks in 7 games last month. I felt like we had been robbed of good feelings that we would share watching the Sox (and Cubs) play in the 2003 World Series. Now, looking back a month later, I cherish the great feelings that we shared together going to the games and following on TV, radio and the internet this past summer. I hope that you'll do the same.

My wishes for your future are that you be healthy and happy. These are things that you cannot buy. May your work be interesting and may you know love from family and friends. Observe the world around you. Certainly an exciting place with many good people and great opportunities. But also a place of pollution, greed, poverty and disharmony. Oh, and my own personal view of summer heat & humidity and bone chilling winters, "the planet is just not inhabitable for humans". Work hard, enjoy the opportunities offered to you. Stay alert and be aware of surroundings and situations. Be on guard. Happy and sad. That's the real world.

Most important of all, seek to know God the Father, the Son and the Holy Spirit. Learn how to talk to each of them and listen. Develop your faith through study of scripture, prayer and good deeds. Remember, Jesus died for your sins, the greatest gift of all. Thus, you can't save yourself. You simply must choose His gift of eternal life. Have a good, fulfilling life. Look to eternity in Heaven with God and all of us.

The "rumble" problem had plagued the antenna system, already in production, for over six years.

Responsibilities included assessment of the line of sight stabilization performance of the existing controller design, identification of the cause of the "rumble" and to design, implement, test and validate an optimal solution in terms of "rumble" free, superior stabilization performance operation, simplicity and minimal cost. This was successfully achieved by performing open loop, closed loop and plant frequency response, and noise PSD, measurements, with a control systems analyzer. Also, a model of the inner analog rate and outer digital-PID position control loops was built up in MATLAB-Simulink using the relevant parameters for the motors, drive amplifiers, sensors, analog circuit integration-lead-lag and digital-PID servo compensation networks, antenna plate mass moments of inertia, gear stiffness and disturbance torques including viscous drag, bearing friction and cable stiffness/spring torques.

The culprit to the "rumble" problem was found to be structural resonances of the antenna support structure and gear drive trains. The solution entailed changing two capacitors in the dual elevation inner analog rate loop low pass filter networks and then adjusting the PID compensation coefficients in the outer digital position loops. This was an elegant solution compared to the alternative of having to tear down and rebuild/stiffen the antenna system support structure and/or change the gear drive trains. The solution was implemented and demonstrated on two systems in the lab with satisfactory results. This was well received by Telephonics Corporation leading to follow on work including upcoming design, test, analysis and evaluation of spinoff antenna system with smaller antenna blades.
