#### PROBABLE CAUSE STATEMENT FOR ARREST WARRANT

The facts in this statement come from my personal observations and my training and experience. This statement is intended to show merely that there is sufficient probable cause for the requested warrant and does not set forth all of my knowledge about this matter.

- 1) That on January 4, 2022, I met with Hayley Philbrick at the Jaffrey Police Department in regard to her receiving a threatening text message from the number 802-432-5835. Hayley reported that this number was called after receiving the text message, which gave an automated message of the number belonging to TextNow. The message received stated, "You guys left the house and now we are going to break into it."
- 2) Hayley Philbrick showed me additional messages, which indicated they were being sent from someone who identified themselves as Alyssa Acres. She described a history of issues with Alyssa Acres and her family, with this being a continuation of their problems. Hayley provided a written statement about receiving the text message. She signed the statement, which she swore to, and I signed the statement form as a Justice of the Peace.
- 3) I subsequently spoke with Alyssa Acres. She denied the allegations and claimed Hayley Philbrick was making a false report in order to get her in trouble. She described a previous incident where this had occurred and her belief this was a repeat of the previous time.
- 4) A search warrant for TextNow, Inc was applied for and granted. The search warrant was for subscriber information, call logs, messages and IP Address data related to the TextNow number that Hayley Philbrick received the threatening message from. I found the account was registered to Hayley Philbrick's email address, which was the same email address she used to send me screenshots of the messages she received. I also found the messages were sent from a Verizon phone and associated with two different Comcast IP addressed. The IP address associated with the threatening message showed a geographical location associated in an area covering Jaffrey while the IP address associated with the original messages received is associated with a geographical area covering Hayley Philbricks hometown of Winchester.
- 5) I subsequently spoke with Hayley Philbrick about what I had learned. She continued to deny sending the messages to herself, claiming her account was hacked and someone was setting her up. Despite an explanation of the evidence against her, she denied sending the messages to herself.

TextNow, Inc

- 6) TextNow is a VoIP (Voice over Internet Protocol) service that allows users to text and call any number in Canada & the USA. Additionally are able to purchase credits to make international long distance calls. TextNow provides the user with a real phone number which can be used on any smartphone, tablet or desktop computer with an Internet connection. The application can be used on multiple devices under the same login at the same time.
- 7) The TextNow app is available for download via the App Store for most iOS devices such as the iPod touch, iPad and iPhone, and on the Google PlayStore for Android devices (including Android smartphones and Android tablets). We also have applications available for download on our website for Windows and Mac computers, and computer users can also access the TextNow service through our website with their web-browser.

8) When you sign up for TextNow, we ask you to enter a valid email address. We'll ask you to create a unique username for your account, as well as entering your first and last name and birth date. You can also choose to sign up through your existing Facebook account, by entering your Facebook email address and Facebook password. Web and Android users can also use their Google account to log into TextNow.

#### CONCLUSION

- 9) Based on the foregoing information, there is probable cause to believe that Hayley Philbrick has committed the offenses of NH RSA 641:4 [False Reports to Law Enforcement] and NH RSA 641:2 [False Swearing] and NH RSA 641:6 [Falsifying Physical Records].
- 10) The elements of the offense of False Reports to Law Enforcement being:

A person is guilty of a misdemeanor if he knowingly gives or causes to be given false information to any law enforcement officer with the purpose of inducing such officer to believe that another has committed an offense

11) The elements of the offense of False Swearing being:

A person is guilty of a misdemeanor if he makes a false statement under oath or affirmation or swears or affirms the truth of such a statement previously made and he does not believe the statement to be true if the statement is one which is required by law to be sworn or affirmed before a notary or other person authorized to administer oaths

12) The elements of the offense of Falysifying Physical Records being:

Believing that an official proceeding, as defined in RSA 641:1, II, or investigation is pending or about to be instituted, he makes, presents or uses any thing which he knows to be false with a purpose to deceive a public servant who is or may be engaged in such proceeding or investigation
